Information sought :

The appellant filed an RTI Application dated 25/01/2026 seeking Details regarding all documents related to MTS staff working under disposal of DACO, Aalo.

As per the case record, PIO did not furnish the sought information.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tania June on **18/09/2025** filed an RTI application under Form-'A' before the PIO-cum-DACO, Aalo, West Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not received the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/02/2026** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 04/A/2026** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 17/08/2026. In this hearing of the appeal on 17th day of August, 2026, Appellant Shri Tania June and the PIO-cum-DACO, Aalo, West Siang District found absent. However, the appellant has submitted a letter addressed to the Commission stating that all the information sought has been furnished by the PIO and is satisfied and requested to dispose of the appeal case No. APIC-04/A/2026.

Request accepted and the appeal case is disposed of and closed.
