ORDER

- 1). This is a complaint under Section 18(1) of RTI Act, 2005 filed by Shri Pangea Tinkhatra Mahadevpur-I, P.O. & P.S. Mahadevpur, District Namsai, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(PWD), Govt. of A.P., Department of Public Works Department. Kanubari Division, District Longding, Arunachal Pradesh, as sought by the complainant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/03/2025 regarding Model Degree College, Kanubari.
- 2). The 1st hearing was held on 21st October' 2025 (Tuesday) at 1100 Hrs. Both the parties were present during the court hearing. Shri Pangsea Tnigkhatra, Appellant informed that he had received information copies on 20/03/2025 @ Rs. 1026/- for entire set of documents. However, two enclosures were found missing, though the same were mentioned in the covering letter. The Appellant admitted the mistake he made in signing for the documents without verifying the correctness of the contents.
- 3). Shri Taba Peri, AE, APIO represent the PIO-Cum- EE(PWD), Kanubari Division had brought the remaining documents and handed over the same to the Appellant during the court hearing. The Appellant expressed satisfaction on receipt of the balance of information.
- 4). Based on the input provided by the Appellant, the Commission observes it fit to dispose of the case.

Therefore, the case is disposed of.
