**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram, Bengia Tahar & Shri Lokam Namdu on **13/01/2025** filed an RTI application under Form-'A' before the PIO-Cum- EE, Power (Elect) Miao Division Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17/02/2025**, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08/04/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-308/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> hearing on **25//09/2025.**

**Details of information as sought by the Appellants.**

1. Particulars of information: To furnish all the relevant information against the your earlier furnished RTI Sanction order which Specified the name of works under (UNTIED FUND) and also from 2016-2024 are given below:-
2. Providing of Supply from Nampong to Boarder Hoal at Pangsa pass phase-ii Rs.50.00
3. Lighting provision at Nampong Sports Stadium Rs.12.00
4. Lighting Provision at Diyun Sports Stadium Rs.12.00
5. C/o 33/0.433kv power Sub-station of various capacity at Miao & kharsang Rs.50.00
6. Shifting of 11kv motongsa feeder from Ashoka vihara, Rima village Rs.15.37
7. . C/o 11kv dedicated Line from Rima to Motongsa village via wingtong & old Longchong Rs. 40.00
8. Illumination of Setong Sena Outdoor Stadium Jairampur Rs. 7,50,000.00
9. Lighting provision for Bordumsa General ground Rs.5.00
10. Strengthening of 33kv HT Lines from Jagum 9th mile to Jairampur Rs. 25.00
11. Give the DPR Copy/Coloring Photocopy of Geo-tag Report of work wise.
12. Give the work order/Supply order/quotation/Technical sanction order copy/Cash memo of materials with details moods of contractor bill payment like Xerox copy of Cheque leaf/demand draft/banker cheque/RTGS slip/Money receipt/Treasury challan made by department as per above mentioned work. Payment must be made as per sanction/work order.
13. Give the Money Receipt List of Contractor bill Payment with their name & cntct no
14. Give the Xerox copy of firm Trading Licence with contact number of Proprietor.
15. Give first & final bill copy of all the works with enclosed of contractor bill payment like Xerox copy of Cheque leaf/demand draft/banker cheque/RTGS slip/billing voucher/Treasury challan paid as per the above Specified work. All the Payment should be made accurately to amount which mentioned in Sanction/work order.
16. Give the details of billing Sheet/scheme Sheets copy of work wise.
17. Give the Xerox copy of Cheque leaf/banker Cheque/demand draft/RTGS/treasury Challan/billing voucher of Contractor bill payment as per the above mentioned work and all the bill payment Should be made as according to amount of Sanction/work order



18. Give the MB records/Cashbook Statement from 2016 to till date.
19. Give the Payment List of Contractor/Hand receipt with payees name.
20. Give the details of deduction amount from contractor bill payment as percentage as per the Govt. guidelines.
21. Give the Certified Coloring Photocopy of all the work Sites by Concern Pio.
22. Give the Coloring photocopy/videography of every work site which might be before starting of work/Starting of work and ending of work.
23. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/buris of concern village/block.
24. Give Name of Officers & Officials with their Signature/Seal, Who hold the DDO Power to approved the financial matter or handled the W...
25. Give details of Enlistment of contractor as per work department Rules Act 2008.
26. Give details of proprietor of firm/Registration of certificate.
27. Give the Money deposited Challan of Govt. account against GST/Royalty by department/firm.
28. Give the Challan/Cash memo of Supplied Materials with Carriage Vehicle number.
29. Furnish the Work order copy of all the above mentioned works with Exact amount

In the 1<sup>st</sup> hearing on **25<sup>th</sup> day of Sept '2025**, the Appellants found absent, but a letter dated **06/05/2025**, was submitted to the Commission yesterday on 24/09/2025.

The PIO –cum, Executive Engineer Power ( Elect) Miao Division District Changlang Govt. of AP, found absent during the hearing without intimating the reason for his inability to attend the hearing.

The Appellants Shri Riya Taram, Bengia Tahar & Lokam Namdu, have submitted a letter dated **06/09/2025**, to the Commission stating that they have received all the information(s) as sought in their Form 'A' application from the PIO and have requested the Commission for disposal/closure of their appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
