Information sought :

The Complaint filed an RTI Application dated 16/02/2026 seeking Details regarding all Schemes, State CAMPA Scheme and maintenance work for the financial year- 2018-19 to 2025-2026.

As per the case record, PIO did not furnish the sought information.

Feeling aggrieved and dissatisfied, Complainant approached the Commission with instant in this case.

JUDGEMENT ORDER

This is an appeal filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the Complainant Shri Lebe Lamnio on 16/02/2026 & 19/03/2026 filed an RTI application under Form-'A' before the PIO-cum-DFO, Likabali Forest Division, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as

quoted in Form-A application. The Appellant, on non receipt the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **31/03/2026** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 10/C/2026** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 17/08/2026. In this hearing of the appeal on **2nd day of September, 2026**, the PIO-cum-DFO, Likabali Forest Division is represented by his counsel Adv. Lizar Bui through VC but the complainant Shri Lebe Lamnio found absent. However, he sent a letter addressed to the Commission requesting to dispose of the complaint case.

Request accepted and the complaint case No. 10/C/2026 is disposed of and closed.

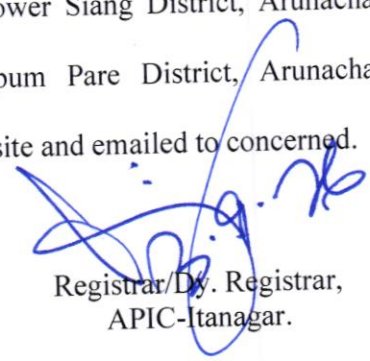
