4. Furnish the true copy of the written examination date and the examination centre of the above mentioned post and the photocopy of the Question Paper vis of vis it's serial numbers and the true copy of answer sheet if it's available.
5. Furnish the true copy of the date of the interview to the successful applicants and furnish the true copy of interviewer penal list of the abovementioned post.
6. Furnish the true copy of the pay scale of **Miss Phime Shoju** at the time of her initial appointment order and as of now.
7. Furnish the true copy of viva voice/personal interview mark sheet of **Miss Phime Shoju** if it's available.
8. Furnish the true copy Recruitment Rules (RR) under DDSE and vice versa of the state Government.
9. Furnish the true copy of office nothing or nothing if any.
10. Furnished copy of MLA notes or recommendation (if any).

Period for which information asked for: 2018 to 2023.


