ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on 5/7/2023, filed an RTI application under Form-'A' before the PIO-Cum- EE (RWD) Daporijo Division District Upper Subansiri, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 7/8/2023, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 6/9/2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 739/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission three times i.e on 03/12/2024, 13/02/2025, & 3/07/2025, details of information(s) sought from the PIO.

2. Furnish the certified Sanction Order Copy.
3. Furnish the certified copy of Utilization Certificate.
4. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
5. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, with respect to the subject mention above.
6. Furnish the Tender Evaluation Copy along with list of Firms participated in the Tender processed for the work.
7. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
8. Furnish the Full Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.

9. Furnish the certified copy of Completion Certificate for the work with respect to the subject mentioned above.
10. Furnish the certified Payment Details made through PFMS under DBT only, with respect to the subject mentioned above.
11. Furnish the Geo Coordinate information for the work mentioned above.
12. Furnish the Photograph of worksite (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.
13. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
14. Furnish the certified copy of Contractor Registration, Pass work Completion, Trading License, GST No., Contractor Enlistment Update reports, T&P Affidavit copy of tender winning Firm.

In the final hearing on **3rd day of July'2025**, the Appellant present in person before the Commission. The PIO found absent.

The Appellant Shri Tamchi Gungte, has submitted a letter to the Commission on **09//4/2025**, stating that he has received all the information(s) as sought in his Form 'A' application and have requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.


