**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC-550/2025**

**RESPONDENT** : The PIO, o/o the Executive Engineer (RWD), Likabali Division, Lower Siang District(A.P)

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, Shri Bengia Tahar & Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o Executive Engineer (RWD), Likabali Division, Lower Siang Siang District Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 17.03.2025.

**A) Particulars of information:** To furnish all the relevant Information as per the copy of your earlier furnished RTI documents which specified name of the Scheme list and name of Agency sanctioned amount under the funding head of fund : non BADP and UNTIED FUND 2019-2024.

**B) Details of information Required:**

1. Furnish the Technical/Sanction order copy/Work Order Copy/LOC/first & final bill Copy with details of Payment like Xerox copy of Cheque Leaf/demand draft/banker Cheque/Pay in Slip for NEFT/RTGS which paid against name of above mentioned work and name of Agency list.
2. Give the Name of Contractor/Agency with their bank account number.
3. Give the Money Received List of Contractor/firm bill Payment with their name & contact number of person who received the payment.
4. Give the Xerox copy of Trading License of firm/Agency with contact number of Proprietor/Agreement copy of work which carried out by department and contractor.
5. Give the details of billing Sheets/scheme Sheets copy of work wise.
6. Give the details of MB records/Cashbook Statement.
7. Give the Certified Coloring Photocopy of all the work Sites by Concern Officer.
8. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/Gaon buris of concern village/block.
9. Give Name of Officers & Officials who carried out the Works.
10. Give details of Enlistment of contractor as per work department Rules Act 2008.
11. Give details of proprietor of firm/Registration of certificate.
12. Give the Money deposited Challan of Govt. account against GST/Royalty by department/firm in work wise.

**C) Period from which information asked for: 2019-2024.**

Records in the appeal reveal that the appellants had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Chief Engineer (RWD), Western Zone, Govt. of A.P. Itanagar under section 19(1) of the RTI Act vide their Memo of Appeal dt. 21.04.2025.

The records also reveal that the FAA conducted a hearing on 6<sup>th</sup> May, 2025 but the appellants were absent. As such the FAA disposed off the appeal presuming that the appellants are no more interested in the case. The judgement order of the FAA is reproduced below :

*“JUDGEMENT/ORDER*

*The 1st Hearing related to RTI No RWD/RTI-210/2024, regarding Non-BADP & Untied Fund 2019-24 held on 06/05/2025 at 1430 hrs in the office chamber of FAA-cum Chief Engineer W/Z). RWD, Itanagar.*

*The Appellants were absent and the Respondent- Er. G Don, PIO-Cum-EE, RWD, Likabali Division, was present.*

*The respondent while referring to notice no. APIC/C10/09/2024 dated Itanagar the 19/11/2024 (enclosed) stated that the applicant is seeking information for multiple years and multiple number of schemes, which could be provided by the division and hence the appellant may seek information for particular scheme for particular year.*

*However, as the Appellants were absent, the FAA feels that the Appellant is no more interested in the case and this appeal is fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for al*

*Liberty to the Appellant for filing second appeal for the instant case if not satisfied with the decision of the FAA*

The appellants, being aggrieved with the judgement of the FAA as above, preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 28.05.2025.

This appeal is, accordingly, listed today on 06.03.2025 but none appeared.

This Commission taking a serious view of the absence of the parties, particularly, the appellants, concludes that they are no longer interested in the requested information/documents or they have received the information from the o/o the PIO and therefore, no adjudication is required in this Commission. Resultantly, this appeal stands closed as not being prosecuted and in terms of the stipulation contained in the Summon Notice that in default of appearance, on the day of hearing, the matter will be heard and determined in your absence.
