#### JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June**, **C/o Post Office**, **E-sector Naharlagun**, **Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-BDO**, **Manigaon CD Block**, **West Siang District**, **Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 20.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details regarding Expenditure and Implementation of work under MGNREGA/ Supply Work/ Pending Work/ New Work/ Sanction Order/ Complete Work."

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing for the case was held on the 22<sup>nd</sup> day of November'2023. Both the PIO and appellant were present. After hearing both the parties, the PIO informed Court that he hadn't received the Form-A of the applicant till date. After receiving the Summon Notice through WhatsApp, the PIO had brought the information and submitted to the appellant during the hearing of this case. The appellant had received the same and also pleaded to furnish the documents in hard copies of certain documents which are uploaded in the Ministry Website. The PIO was directed by the Court to do the same. Also, the Court directed the PIO to forward the documents that are not available in his custody to the appropriate authority where the documents could be found. The appellant is directed by the Court to go through the documents received and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case. The next date of hearing of this case is fixed on the 20<sup>th</sup> day of Dec'2023.

The 2<sup>nd</sup> hearing of this case was held on the 20<sup>th</sup> day of December'2023. The representative of the PIO, Shri T. Tadap (Program Asst.) was present. The appellant was also present. After hearing both the parties, the appellant informed the Court that the documents as sought by him had already been provided by the PIO during its previous hearing and after going through the same, he is fully satisfied with the information provided by the PIO and pleaded before the Court for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
