Information sought :

The appellant file an RTI Application dated 14/10/2024 seeking Details regarding release of fund against Pradhan Mantri Gram Sadak Yojna Schem IPFMS Scheme Code: 9179 (State Scheme Code: AR 59) and Special repair & maintenance of PMGSY road from Suple Bridge point to Yibuk Village.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 28/11/2024. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Serpi Flago on 14/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (RWD), Pangin Division, Siang, District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A

application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **31/12/2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 64/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 26/05/2025 and 06/10/2025. In this hearing of the appeal on **6th day of October, 2025**, both the parties Appellant Shri Serpi Flago and the PIO-cum-EE (RWD, Pangin Division found absent.

On the last hearing dated 26/05/2025 PIO had brought all the information and handed over to the appellant before the Commission. The appellant was given time to go through all the documents and intimate to the Commission within 10 days. No intimation has been made by the appellant.

Therefore, the Commission deems that the appellant is satisfied by the information provided and the appeal case is disposed of and closed
