Information sought :

The appellant file a RTI Application dated 01/04/2025 seeking Details regarding Tender No. NIT/WRD/SGI/SMI/2024-25.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 13/05/2025. First Appellate Authority had conducted hearing in his jurisdiction on 25/06/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Respondent : PIO-cum-EE(WRD), Sagalee Division absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Nanu on **01.04.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (WRD), Sagalee Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13.05.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17.09.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 707/A/2025**.and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 11/02/2026 & 08/04/2026. In this hearing of the appeal on 8th day of April, 2026, both the parties the appellant Shri Nabam Nanu and the PIO-cum-EE (WRD), Sagalee Division present in person.

As per the order dated 08/04/2026, all the documents sought by the appellant had been handed over to the appellant and the appellant was directed to go through the documents and intimate to the Commission within one week. But till date there is no any intimation from the appellant. Therefore, the Commission presumes that the appellant is satisfied by the information provided to him.

Therefore, the appeal case No. APIC-707/A/2025 is disposed of and closed.
