JUDGEMENT ORDER

VS

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Nabam Tapak, Village - Lekhi, Near Iconic Dealer Backside, PO- Model Village, PS - Nirjuli, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-cum-Executive Engineer, Public Works Department, Sagalee Division, District – Papumpare, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 21.04.2021 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Furnish the details of maintenance of asset road, Bridge and Building/Housing from 2018-2021. Furnish the details of non-plan maintenance of asset road, bridge and building/housing etc 2018 to 2021."

The above subject has been mentioned in detail under 'Form - A'.

The 1st hearing for the case was held on 08th day of November' 2021. Both the parties were present. Heard both the parties. The appellant informed the Court that the PIO still hasn't furnished the information sought by hum under Form-A. In this the Court directed the PIO to furnish the documents on or before the next date of hearing. Accordingly, the Court fixed the next date of hearing for the case on 17th November' 2021.

The 2nd hearing for the case was heard on 17th day of November' 2021. The appellant and PIO both were absent. APIO, Nabam Zomleen(AE) represented the case on-behalf of the PIO. The APIO furnished the documents before the Court itself. Since the appellant was absent the Court directed the APIO to furnish the documents to the appellant in a week's time in their Office. Accordingly, the Court fixed the next date of hearing for the case on 19th January' 2022.

The 3rd hearing for the case was heard on 19th day of January' 2022. Both the parties were present. Heard both the parties. The appellant informed the Court that the documents furnished by the PIO were incomplete. In this the PIO replied to the appellant that some of the documents sought by the appellant were not available with them. Hence, the Court directed the PIO to furnish in affidavit form for the N/A documents to the appellant on or before the next date of hearing. Accordingly, the Court fixed the next date of hearing on 02nd of March' 2022.

The 4th hearing for the case was heard on 02nd day of March' 2022. Both the parties were present. Heard both the parties. The appellant informed the Court that the allotment copy hasn't been furnished and the affidavit provided needs few modification. The Court directed the PIO to furnish both the documents in clear format on or before next date of hearing. Accordingly, the Court fixed the next date of hearing on 20th of April' 2022.

The 5th hearing for the case was heard on 20th day of April' 2022. The appellant was present but the PIO was absent. The APIO, Er. Nabam Zomleen (AE) represented the case on-behalf of the PIO. The APIO refurnished the left out documents and the Affidavit before the Court itself. The appellant had gone through the documents after receipt from the APIO. Later, the appellant expressed his satisfaction for all the documents received and pleaded before the Court to dispose of the case. As such the Court ordered to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
