Information sought:

The appellant has filed an RTI application dated 22.04.2026 seeking following information:

Details of information required;

1. Furnish a copy of the appointment orders of the following W/C Staff/regular: (a) Toffy Ango Doji, (b) Nyamik Loyi Ado, and (c) Ijum Naso.
2. Furnish a copy of the Back Log details before the appointment of (a) Toffy Ango Doji, (b) Nyamik Loyi Ado, and (c) Ijum Naso as W/C Staff/regular and others.
3. Furnish a copy of the list of W/C Staff who have been recently promoted to W/C Staff/regular from Casual Staff in the recent Trade

4. Furnish a copy of the details of D.P.C and list of D.P.C members during the appointment of (a) Toffy Ango Doji, (b) Nyamik Loyi Ado, and (c) Ijum Naso as W/C Staff/regular.
5. Furnish a copy of the approval order from the Chief Engineer, Central Electrical Zone, Department of Power, Itanagar, Vidyut Bhawan, Itanagar Arunachal Pradesh for the appointment under Direct Quota in respect to the appointment of (a) Toffy Ango Doji, (b) Nyamik Loyi Ado, (c) Ijum Naso and others.
6. Furnish a copy of the Post Vacancy Approval Order form the Chief Engineer, Central Electrical Zone, Department of Power, Itanagar, Vidyut Bhawan, Itanagar Arunachal Pradesh.
7. Furnish a copy of an advertisement within A.P Electrical Circle-VI, Aalo, Department of Power for "Open Market" just before/while appointment of (a) Toffy Ango Doji, (b) Nyamik Loyi Ado, (c) Ijum Naso and others as W/C Staffs/regular.
8. Furnish a copy of the name list of Registration who applied for W/C Staff/regular within A.P Electrical Circle-VI, Aalo, Department of Power in the year 2025-26.
9. Furnish a copy of latest Government Notification/ Recruitment Rule for the appointment of the General Service Multi- Tasking Staff (Daftly/Peon/Chowkidar/Mali/Dak Runner/Sweeper/Kennel Man/ Water Carrier/Cook/Washer Man/Cobbler/W/C Staffs/regular and equivalent posts.

The following were present.

Appellant : Absent. However, he has submitted a letter dated 20.08.2026 requesting the commissioner to close his appeal case as he has received satisfactory information from the PIO.

Respondent PIO : Absent. However, he informed the commission vide his letter dated 14.08.2026 that he has furnished the sought information as per his RTI application to the appellant.

Decision:

The commission after adverting to the facts and circumstances of the case and perusal of the records, observes that the PIO has furnished complete information to the appellant. Therefore, this appeal case is fit to be closed.

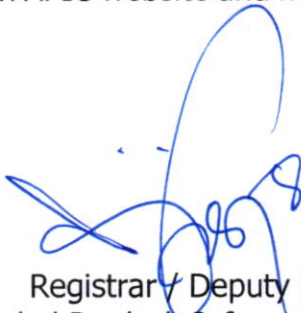
