An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-179/2025.

: Shri Tamchi Gungte, near KV-II School Itanagar.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri TamchiGungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer, RWD, Hawai Division, District: Anjaw, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 01.11.2024.

Particular of information: C/o "L025-PMGSY Road from PMGSY Road (Staging Hut Krosam to Khrawit village during the financial year 2024-25.

- 1. Furnish the certified Sanction Order Copy.
- 2. Furnish the certified PRC (Permanent Residence Certificate) submitted by tender Participant issued by the Competent Authority regarding domicile status with the Districts as per Rule 4(11)(b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
- 3. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territonal jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion), rules, 2015 & 2020.
- 4. Furnish the certified LOC Copy with respect to the subject mentioned above.
- 5. Furnish the certified copy of Utilization Certificate.
- 6. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
- 7. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
- 8. Furnish the certified copy of Completion certificate of the project.
- 9. Furnish the certified copy of Newspaper in which NIT was published {At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order.
- 10. Furnish the certified Design and Scope of Work in the projects.
- 11. Furnish the certified copy of Work Specification of the projects.
- 12. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
- 13. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.

- 14. Furnish the Name of Officers and their Designation at the Time of monitoring the work. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
- 15. Furnish the certified copy of Contractor Enlistment Update reports (Civil/Composite Category as per the nature of work), of tender participant and winning Firm.
- 16. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
- 17. Furnish the certified Integrity Pact submitted by the tender participant.
- 18. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018 as _ per District Based Entrepreneurship Act, 2015 & 2020).
- 19. Furnish the certified documents submitted by tender participant and winning firm, 1.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer . and Chief Engineer, in the last 5 years ending last day of the month *previous to the one in which the tenders are invited.
- 20. Furnish the certified reasons & provision to adopt TURNKEY /EPC Basis to execute this project.
- 21. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm.
- 22. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
- 23. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
- 24. Furnish the certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.
- 25. Furnish the Geo Coordinate information for the work mentioned above.
- 26. Furnish the certified Payment Details (Cheque no., voucher, PFMS etc. (Which ever method is used of payments) } of the project till date.
- 27. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant,
- 28. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
- 29. Furnish the certified Affidavit to invest cash upto (25% of tender value) submitted by the tender participant.

Hearing and decision:

This appeal was heard for 3(three) times on 04.06.2025, 23.07.2025 and 27.08.2025. On 4th June, 2025, wherein the appellant was present in person and the PIO, Er. Shri Bajai Pul, EE was present through VC, this Commission, after hearing the parties had directed the PIO to provide the information duly indexed and countersigned.

The appellant, vide letter dt.17.06.2025, informed that he has received the documents from the PIO on 07.06.2025, but complained that the following documents are either not furnished or are incomplete /unsatisfactory.

- 35. Sl. No.1: Not furnished;
- 36. Sl. No.4 and 5: Replies not justified;
- 37. Sl.No.6, 10, 12, 16,17 and 18: Not furnished;
- 38. Sl.No.19,29,21,25,26 and 27: Not satisfied with the replies.

This appeal was, therefore, listed again on 23.07.2025 but the appellant was absent and hence, the hearing was adjourned to 27.08.2025.

On 27.08.2025, both the PIO, Er. Shri Bajai Pul, EE and the appellant, Shri Tamchi Gungte were present in person and heard in detail.

As regards the copy of sanction order (Sl. No.1), the PIO submitted that other than the sanction order received from the GoI, no sanction order from the State Govt. has been issued in respect of the project in the instant case.

As regards Sl.Nos. 4, 5, 25, 26 and 27, the PIO clarified that since the execution of the project in question has not yet commenced, the requested information have not been furnished but the same will be furnished in due course.

As regards Sl. Nos. 6(NIT), 10(Design),12 (Technical Bid documents) and 16(Enlistment certificate of the Contractor winning the tender), the PIO assured to furnish the same.

As regards Sl. Nos.18 (integrity pact) and 19(affidavit), the PIO submitted that the documents were not obtained from the contractor.

The rest of the left out documents have been furnished by the PIO during the course of hearing with which the appellant has expressed his satisfaction.

This Commission, after hearing the parties and perusing the documents furnished by the PIO, directed the PIO to furnish the left out documents to the appellant before 26.09.2025 and report its compliance on 26.09.2025 the next date of hearing.

In compliance with the order of this Commission, the PIO had brought in the left out documents/information today on 26.09.2025 which have been handed over to the appellant who expressed his satisfaction therewith.

In the premises as above, this appeal does not require any further adjudication by this Commission and resultantly, the appeal is disposed of and closed.
