ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Tania June on **14/08/2023** filed an RTI application in Form- 'A' before the PIO-cum-Executive Engineer, Office of the Chief Engineer, RWD, Western Zone, Itanagar, Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellant not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **19/10/2023**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **08/12/2023** and the Registry of the Commission (APIC) in receipt of the complaint registered it as **APIC-1149/2023 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **28.11.2024, 11.02.2025, 17.04.2025 & 03.07.2025**. Detail of information(s) sought from the PIO;

Regarding expenditure and implementation of under Non-Plan fund/maintenance work etc. repairing work/road and bridge of entire district.

- 13) Furnish utilization certificate copies.
- 14) Furnish EE/AE/JE/Details name list copies.
- 15) Furnish DPR copies.
- 16) Furnish advertisement and local news paper copies.
- 17) Furnish department and contractor agreement copies.
- 18) Furnish payment details name list copies.
- 19) Furnish tender participate details copies.
- 20) Furnish land donate copies.
- 21) Furnish sketch map copies.
- 22) Furnish firm registration certificate copies.
- 23) Furnish firm work express certificate copies.

The Commission observes;

The Appellant Shri Tania June found absent for consecutive three hearings on **28.11.2024, 11.02.2025 and 03.07.2025**. In all the hearings the Commission has issued notices to the Appellants to attend the hearing without fail and that the Commission clearly instructed that on the failure of the Appellants in the next hearing this instant appeal will be decided Ex-parte.

In the final hearing of the appeal 03.07.2025 both the parties are absent without intimating the Commission the reason for their inability to attend the hearing before the Commission.

And therefore, the Commission hereby orders;

The Appellant is not being serious on the appeal and is repeatedly wasting the precious time of the Commission as well as unnecessarily wasting the public resources incurred in sending notices to him. And therefore, this appeal is dismissed Ex-parte.

Order;

In view of the above facts and circumstance the Commission, finds this appeal fit to be dismissed and closed. And, accordingly, this Appeal stands dismissed ex-parte and closed once for all.
