**Information sought :**

The appellant file a RTI Application dated 22/08/2025 seeking Details regarding 132 KV Transmission Line passing through Likabali and Dipa RF under the comprehensive Scheme for strengthening Transmission and Distribution in A.P.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 29/09/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tagi Ruti on **22/08/2025** filed an RTI application under Form-'A' before the PIO-cum-DLRSO, Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **29.09.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 831/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 01/06/2026. In this hearing of the appeal on 1<sup>st</sup> day of June, 2026, both the parties the appellant Shri Tagi Ruti and the PIO-cum-DLRSO, Likabali found absent. However, request letter has been received from the appellant Shri Tagi Ruti to dispose of the appeal case No. APIC-831/A/2025.

Request accepted and the appeal case is disposed of and closed.

APIO stated that all the information sought by the appellant has been furnished to the appellant. The appellant has no objection in closing of this appeal case.

Therefore, this appeal case No. APIC-831/A/2025 is disposed of and closed.
