#### Information sought :

The appellant file a RTI Application dated 30/05/2024 seeking Details regarding DPR, Utilization Certificate, Notice Inviting Tender, Date publication of Newspaper, Tender evaluation copy along with list of firms, completion certificate, payment details etc. against the Project Works /work sanctioned under PMJVK, erstwhile-MsDP Scheme Ministry of Minority Affairs (2021-22).

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 12/08/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

#### JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on **30/05/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/08/2024**, Appellant, again having not received the required information from the FAA filed the Second Appeal before the Arunachal Pradesh

Information Commission on 01/10/2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 264/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 (four) time i.e on 05/03/2025, 05/05/2025, 18/08/2025 and 29/09/2025. In this hearing of the appeal on 29<sup>th</sup> day of September, 2025, both the parties the PIO-cum-EE(WRD), Ziro Division, Lower Subansiri District and the appellant Shri Tamchi Gungte found absent.

As per the order dated 18/08/2025, the document sought by the appellant was already provided to the appellant by the PIO. The appellant has returned back to the PIO after going through the documents stating that the documents provided are not in a sequence and mixture. Again on 3<sup>rd</sup> hearing the PIO brought all the documents for 3 cases APIC-No. 263/2023, APIC-264/2024 and APIC-265/2024 before the Commission. The appellant was directed to collect the information from the PIO and go through the documents and intimate to the Commission on or before next date of hearing.

Today both the parties are found absent without any intimation to the Commission. The Commission presumed that all the sought documents/information has been provided to the appellant and the appellant is satisfied by the information provided.

Therefore, he Commission deemed fit to dispose of the case. Accordingly, the appeal case No. APIC-264/2024 is disposed of and closed.


