Information sought :

The appellant file a RTI Application dated 01/03/2024 seeking Details regarding Renewal and No Objection Certificate copies from the Department of Geology & Mining, Govt. of Arunachal Pradesh for 2024-25 year of all Stone Crusher in the Lower Siang District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 16/12/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tana Roma Tara absent.

Respondent : PIO-cum-AMDO, Likabali attended through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tana Roma Tara on **16.12.2024** filed an RTI application under Form-'A' before the PIO-cum-Assistant Mineral Development Officer (AMDO), Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **08.01.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11.02.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 134/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 17/09/2025. In this hearing of the appeal on 17th day of September, 2025, the PIO-cum-AMDO, Likabali, Lower Siang District attended the hearing through VC but the Appellant Shri Tana Roma Tara found absent. However, the appellant has submitted an application addressed to the Commission stating that all the information as sought has been received from the PIO and requested to dispose of the appeal case No. APIC-134/2025.

Request accepted and disposed of the appeal case.
