JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Tamchi Gungte on **06/11/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer (EE), PWD, Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in his Form 'A' application. The Appellant being not received the required information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **11/12/2025**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **13/01/2026** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **76/A/2026** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter come up for hearing before the Commission on **20.08.2026**, wherein the Appellant is absent with a letter dated 20.08.2026 praying that he has received all the information(s) from the PIO and after satisfying himself with the information furnished by the PIO-cum-EE, PWD, Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh, he prays to dispose of this appeal.

The Commission while going through the letter submitted by the Appellant to dispose of the appeal case filed by the Appellant, consider the prayer.

And hereby dispose of this appeal and close it once for all.
