**Information sought :**

The appellant file an RTI Application dated 26/03/2023 seeking Details regarding Expenditure and implementation of MLA LAD fund of Taring Dakpe, Hon'ble MLA 25<sup>th</sup> (ST) Assembly Constituency.

As per the case record, PIO did not furnish sought information to the appellant.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Buli Bhai & Shri Kabak Povitra on **15.02.2023** filed an RTI application under Form-'A' before the PIO-cum-District Planning Officer, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking

various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18.05.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 453/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for sixteen times i.e on 26/06/2023, 07/08/2023, 25/09/2023, 20/11/2023, 21/12/2023, 02/02/2024, 06/05/2024, 19/06/2024, 21/08/2024, 18/12/2024, 05/02/2025, 19/03/2025, 23/04/2025, 11/06/2025 and 06/10/2025. In this hearing of the appeal on 6<sup>th</sup> day of October, 2025, the PIO-cum- DPO, Raga is represented by Shri Giper Biri, UDC-cum- Accountant and the appellant Shri Buli Bhai & Shri Kabak Povitra found absent without any intimation to the Commission.

As per the last order dated 11/06/2025 all the documents as sought by the appellant was furnished by the PIO and the appellant was directed to intimate to the Commission within 1 (one) week after going through all the documents provided but till today no intimation has been received from the appellant.

Therefore, the Commission deems that the appellant is satisfied by the information provided and do not want to pursue the appeal case further.

Therefore, this appeal case No. APIC-453/2023 is disposed of and closed.
