Information sought :

The appellant file an RTI Application dated 02/05/2023 seeking Details regarding Jaal Jeevan Mission Scheme of Tender and non-Tender copy from Package-19 August for Water Supply at Dugi.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 12/10/2023. The First Appellate Authority has been conducted hearing on 18/03/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Nabam Sonu 02.05.2023 filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PHE & WS), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 12.10.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.11.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 1096/2023/R/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 12/11/2025. In this hearing of the appeal on 12th day of November, 2025, the appellant present and the PIO-cum-Executive Engineer (PHE & WS), Raga Division, Kamle District is represented by Er. Dani Tachang, JE but the appellant Shri Nabam Sonu found absent, however, a letter for disposal has been received by the Commission requesting to dispose of the appeal case.

Request accepted and the appeal case No. APIC No-1096/2023/R/2025 is disposed of and closed.
