An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-859/2025.

APPELLANT : Shri Chow Lajamang, Mannow, Namsai.
RESPONDENT : The PIO, o/o the EE (PWD) Changlang Division, Changlang.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of 14(fourteen) information regarding Work Charged (W/C) Staff under the establishment of EE (PWD) Changlang Division by the PIO o/o the EE (PWD) Changlang Division, Changlang District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.08.2025.

This appeal was listed and heard on 10th April, 2026 wherein both the appellant, Shri C.L. Mannow and the PIO, Er. Shri N. Chiliang, E.E were present in person.

This Commission, after hearing the appellant who submitted that he has received the requested information / documents from the PIO but did not receive the documents at Sl. Nos. (f), (g),(h), (i), (j) and (k) and also upon hearing the PIO who submitted that the above left out documents/information are not held by his office but by the office of the SE, Namsai who made the recruitment, directed the PIO to furnish his submission as above on an affidavit within 1(one) month from the date of receipt of the order dt. 10.04.2026 as required under section -7(8)(i) r/w section-18(3)(c) of the Act r/w rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005. The appellant was also directed to intimate the receipt of the same within same timeline.

The appellant, vide letter dt.12.05.2026, however, complained that the PIO did not comply with the aforesaid order of this Commission. This appeal was, hence, listed on 05.06.2026 with direction to the PIO to comply with this Commission's earlier order and report compliance thereof on the date of hearing but the hearing could not be held on 05.06.26 due to Bandh in Itanagar Capital Region and therefore, the appeal was listed on 17.07.2026 wherein, the appellant, Shri Chow Lajamang Mannow was present through V.C while the APIO, Er. Shri Takhe Rike was present in person with the affidavit in terms of this Commission's order dt.10.04.2026.

This Commission, on a perusal of the Affidavit, however, found that the affidavit furnished by the PIO was not in proper form and the contents therein were also not consistent with the PIO's submission during the hearing on 10.04.2026.

The affidavit furnished by the PIO was, therefore, returned to the APIO vide order dt.17.07.2026 with a direction to furnish to the appellant a revised affidavit in proper form and containing the submission made in the hearing on 10.04.2026 within 1(one) week from the date of receipt of this order with intimation to this Commission. The appellant was also directed to intimate this Commission of the receipt of the revised affidavit within 1(one) week from the date of receipt from the PIO.

This Commission is now in receipt of letter dt.31.07.2026 from the appellant intimating that he has received the requested information through whatsapp from the PIO and that this appeal be disposed of and closed.

In te premises as above, this appeal stands disposed of and closed.
