EX-PARTE JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Tania June on **27/05/2025** filed an RTI application in Form- 'A' before the PIO-cum-DLRSO, Palin, Kra-Daadi District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in his Form 'A' application. The Appellant being not receiving the information from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **26/07/2025**. The Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/09/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **720/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **22.01.2026** and on **23.04.2026** wherein the Appellant found absent during the two hearings before the Commission.

The PIO-cum-DLRSO, Palin, Kra-Daadi District, Govt. of Arunachal Pradesh found absent but submitted a letter through WhatsApp message to the Commission stating that his office is not the competent authority to appoint any staffs and employees under his office, and therefore, he cannot provide the information(s) as applied by the Appellant.

Details of information(s) sought from the PIO;

1. Furnish appointment order Copies
2. Furnish Class X Pass Certificate Copies.
3. Furnish Joining Report Copies.
4. Furnish class XII pass certificate Copies.
5. Furnish Seniority list copies.
6. Furnish DPC copies.
7. Furnish advertisement and local news paper copies.
8. Furnish ST/PRC Certificate copies.

Period from which information asked for; 2018 to till date.

In the second hearing held on 23rd day of April' 2026 the Appellant found absent continuously for the 2nd time as he was also absent in the first hearing held on 22nd January' 2026 without reporting the reason for his absence in the hearing.

The PIO-cum-DLRSO, Palin, Kra-Daadi District, Govt. of Arunachal Pradesh is absent.

In the absence of both the parties the Commission hereby observes;

- i) The Appellant continuously absent in the hearing without reporting the reason for his absence to the Commission despite being notified for the hearings on 03.11.2025 &

- 23.01.2026 wherein it was clearly mentioned that in the continued absence of the Appellant, this appeal will be heard and determined ex-parte.
- ii) Despite 2(two) notices for hearing sent to the Appellant by the Arunachal Pradesh Information Commission (APIC), the continued absence of the Appellant is taken as intentional absence and no more interested in pursuing the hearing of this appeal.
 - iii) The PIO-cum-DLRSO, Palin, Kra-Daadi District, Govt. of Arunachal Pradesh was present during the first hearing held on 22.01.2026, wherein he stated before the Court that the information sought by the Appellant are vague and the Appellant does not have any locus-standii to seek for the same information.
 - iv) Though absent today in the hearing the PIO has submitted a letter through Whatsapp messenger to the Commission stating that his office is not the competent authority to appoint any staffs and employees under his office, therefore his office does not have the information applied by the Appellant.

Under the above observations the Commission hereby decides;

The continuous absence of the Appellant despite being sent the notice for the first hearing and summons sent for the 2nd hearing prompts this Commission to dispose of this appeal ex-parte and close it once for all.

Order;

In view of the above facts and circumstance the Commission dispose this Appeal. And, accordingly, this Appeal stands disposed of and closed once for all.
