JUDGMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Bachunum Yun on **05/08/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer (EE), PWD, Anini Division, Dibang Valley District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **26/11/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/01/2026** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **150/A/2026** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **26.05.2026 & 04.08.2026.**

Details of Information sought from the PIO;

1. Certify true copy of work charged (W/C) staff serving under your division.
2. Certify true copy of appointment letter of all the work charged W/C staff, serving under your division.
3. Certify true copy of place of posting of all the W/C staff serving under your division.
4. Certify true copy of DPC, trade test of all the W/C staff serving under your division.
5. Certify true copy of board members formed of W/C staff recruited under your division.
6. Certify true copy of Recruitment Rule (RR) of Work Charged (W/C) staff from GOAP.
7. Certify true copy of CPWD/ WC Establishment Rule of W/C Staff,
8. Certify true copy of Present Strength and Total Strength of W/C Staff under your division.
9. Certify true copy of W/C Staff attached to CE (EZ) PWD etc from your division.
10. Certify true copy of attendance register of all the W/C Staff serving under your division.
11. Certify true copy of W/C Staff recruited from other district of Arunachal Pradesh with name, Contact no, Aadhar card, Pan card, PRC, ST, Service Card etc.

In the second hearing held today on 04.08.2026 the Appellant is present through online mode during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), PWD, Anini Division, Dibang Valley District, Govt. of Arunachal Pradesh is represented by Shri Milo Tade, Assistant Engineer, Anini Sub-Division, PWD, Govt. of Arunachal Pradesh during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the information that was remaining to be provided to him pertaining to S/No. K of his Form-A has been provided to him by the PIO, but the information pertaining to S/Nos. F & G have not been provided to him till date.

Heard the representative of the PIO;

The representative of the PIO stated that in the last order of the Commission it had specifically ordered the PIO to provide the information listed under S/No. K of the Form-A of the Appellant and office of the PIO has honored the order of the Commission by providing the information to the Appellant.

Regarding the information sought under S/Nos. F & g of the Form-A of the Appellant, the PIO has clearly written to the Appellant that the said information can be obtained from the office of the Superintendent Engineer (SE), PWD, Tezu Circle, as the office of the SE, PWD, Tezu Circle is the competent authority to appoint W/C staffs and Recruitment Rules (RR) are also available in the office of the said authority and constitution of the Board Members is also done by the same office. The office of the PIO is incompetent to appoint W/C Staffs, and hence, the office of the PIO is not able to provide the information pertaining to S/Nos. F & G of the Form-A of the Appellant, except, clearly writing and suggesting the Appellant where the said information can be obtained from.

The letter to the Appellant has been written to him on 04.09.2025 and posted through Registered Post and the Appellant has acknowledged the receipt of the same.

After hearing both the parties, the Commission hereby observes;

- I) That the information available with the office of the PIO have been furnished to the Appellant.
- II) The information that the PIO does not have been clearly given in written to the Appellant suggesting him the office of the concern authority from where it can be procured/obtained.

Under the above observations, the Commission hereby is of the opinion that the PIO has provided the information available in his office to the Appellant and also has done the needful for the information that are not available in his office by clearly writing to the Appellant and suggesting him the office from where the Appellant can obtain the information.

Under the above observations and following the procedural law, the Commission hereby dispose of this appeal for the reason that the PIO has carried out his duties as given under

RTI, Act, 2005, and hence, there is no further need to hear this appeal, and therefore, this appeal is disposed of and closed once for all.

Under the above observations and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed.
