**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Ngwazosa Yubin on **19/05/2025** filed an RTI application under Form-'A' before the PIO-Cum- BDO, CD Block, Vijaynagar Changlang District Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **07/07/2025**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/09/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-701/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> hearing on **12//03/2026** .

**Details of information sought by the Appellants.**

- 1. Furnish the total fund allocation under MGNREGA in 2020.**
- 2. The detailed of beneficiaries list of MGMNREGA 2020.**
- 3. The Detail list of DBTL Bank transaction of the beneficiaries.**
- 4. Location of the works with photography of before and after.**
- 5. Geo tagged location where works have been executed.**
- 6. Utility Certificate (UC) & audit reports of the finalized accounting officer (FAO).**
- 7. Works complete reports.**

In the 1<sup>st</sup> hearing on **12<sup>th</sup> day of March '2026**, the Appellant found absent, with a letter **dated 22/12/2025**, submitted to the Commission the day before. The PIO -cum, Block Development Office (BDO) Vijaynagar CD Block Changlang District, found absent during the hearing without intimating the reason for his inability to attend the hearing.

The Appellant Shri Ngwajosa Yubin, has submitted a letter to the Commission on 22/12/025 stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of this appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
