**FACTS OF THE CASE**

The appellant filed an RTI application dated **27.03.2023** seeking **information regarding cultivation of Elaichi Garden at Hiri Darcha under west Siang District.** The PIO-cum-PD, Aalo did not furnish any reply to the RTI application. The appellant then filed the First Appeal dated **28-04-2023.** The First Appellate Authority's (FAA) order, if any, is not available on record. Feeling aggrieved and dissatisfied, the appellant approached commission with the instant Second Appeal.

**FACTS EMERGING DURING THE HEARING:**

After receipt of the second Appeal notices were issued to the parties to appear on 27.10.2023.

The PIO appeared on 27.10.2023 and submitted that requested information had already been provided vide letter dated 17.08.2023. The appellant who was also present during the hearing submitted that the information furnished by the PIO was far from satisfactory and pleaded

that correct and complete information should be provided to him. The commission after hearing both the parties directed the PIO to furnish complete information to the appellant and appear on 19.01.2024.

None appears before the commission. However, a letter dated 22.11.2023 has been received from the appellant. Perusal of the written submission sent by the appellant reveals that he is satisfied with the information furnished by the PIO. He has also requested the commission to dispose of the case. Perusal of the said letter further reveals that the PIO has complied with the directions of the commission.

**DECISION:**

Keeping in view the facts of the case and the written submissions received from the appellant, the commission is of the opinion that the PIO has complied with the order dated 27.10.2023 passed by the commission. Hence, no further intervention of the commission is required in the matter. The instant appeal stands **disposed of accordingly**.
