## **JUDGEMENT ORDER**

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Maji Tayem, Near Doimukh, Short-cut(Hanging Bridge), Nirjuli, ICR, Arunachal Pradesh, for non-furnishing of information, by The PIO-O/o The Chief Secretary, Department of Panchayat Raj, Itanagar Civil Secretariat, Govt.of AP, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 30.05.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"O/o The Secretary, Panchayat Raj, Itanagar, Civil Secretariat, Govt. of AP".

The above subject has been mentioned in detail under 'Form - A'.

The 1<sup>st</sup> hearing was held on 23<sup>rd</sup> day of November' 2022. Both the parties were present. Heard both the parties. The PIO had pleaded before the Court to grant few days' time to furnish the documents sought by the appellant. The Court granted the same and directed to furnish the documents to the appellant on or before next date of hearing fixed on 21<sup>st</sup> December' 2023.

The 2<sup>nd</sup> hearing was held on 21<sup>st</sup> day of December' 2022. Both the parties were present. Heard both the parties. The Court directed the PIO to clarify the term "Ordinary Resident" to the appellant as per his Form-6-A item no 1 (c) on or before the next date of hearing fixed on 18<sup>th</sup> January' 2023.

The 3<sup>rd</sup> hearing was held on 18<sup>th</sup> January' 2023. Both the parties were present. Heard both the parties. The PIO had been directed to clarify the term "Ordinary Resident" to the appellant on or before next date of hearing fixed on 08<sup>th</sup> February' 2023.

The 4<sup>th</sup> hearing was held on 08<sup>th</sup> day of February' 2023. Both the parties were present. Heard both the parties. The Court directed the PIO to sworn in an affidavit for no records of 'Ordinary Resident' term on or before next date of hearing fixed on 22<sup>nd</sup> February' 2023.

The 5<sup>th</sup> hearing was held on 22<sup>nd</sup> day of February' 2023. Both the parties were present. Heard both the parties The PIO furnished the remaining documents to the appellant before the Court itself. The appellant received the same and later expressed his satisfaction for all the documents received and pleaded for disposal of the case. Hence, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
