**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Chali Simit, Village-Manfaiseng, P/O- Nanam Shyam, Namsai District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO) –cum-BDO, O/o Deputy Director, Rural Development Department Namsai, Namsai, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/09/2025 regarding c/o MIC with farm pan at Manfaiseng and c/o MIC at Nanam Khamyang village.
- 2). The 1<sup>st</sup> hearing was held on 24<sup>th</sup> March' 2026. The Public Information Officer (PIO) –cum-BDO, O/o Deputy Director, Rural Development Department Namsai, Namsai, Arunachal Pradesh was represented by Shri B.B. Singh, APIO-cum-RE, O/o Deputy Director, Rural Development Department Namsai through online video conferencing. The Appellant Shri Chow Chali Simit had appeared before the Commission's court through online video conferencing.
- 3). During the 1<sup>st</sup> hearing, the Commission had directed the Appellant to visit the office of the PIO on 7<sup>th</sup> April'2026 and collect remaining information after verification, and inspect the Measurement Book. The Appellant was given liberty to take photograph of the required pages of the Measurement Book.
- 4). The Appellant was asked to intimate his satisfaction or dissatisfaction to the Commission after receipt of information. Caution was given to the Appellant that in case the Appellant failed to intimate, within ten days from the expiry of above time given to the PIO, the case would be disposed of.

5). Since, the Appellant has not intimated as directed, the Commission decided to dispose of the case.

6). Therefore, the case is hereby disposed of.
