ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nilo Bagang for non-furnishing of below mentioned information by the PIO o/o the Executive Engineer, PWD, Yomcha Division, West Siang District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20-05-2025 :

Details of Information

1. True copy of fund allotted for salaries, honorium, TTA, LTC, DTE etc. (W-E-F April 2019 to date).
2. True copy of fund utilisation which was/is allotted for salaries, honorium, TTA, LTC, DTE etc. with bank posting/credit voucher along with the bank seal (W-E-F April 2019 to till date)..
3. True copy of detail salary bill of all the staffs (W-E-F April 2019 to till date).
4. True copy of reconciliation meeting (W-E-F April 2019 to till date).
5. True copy of additional fund requirement/additional fund demand made by E.E (W-E-F Ap 2019 to till date).
6. True copy of monthly expenditure report (W-E-F April 2019 to till date).

Period for which information asked for : 07 to 15 days.

This appeal is listed for hearing today on 27th March, 2026. The Appellant, Shri Nilo Bagang vide his letter dtd. 23.03.2026, has, however, informed this Commission that he has received the requested information/documents from the PIO and that this appeal be, therefore, disposed of and closed.
