Information sought :

The appellant file an RTI Application dated 19/02/2025 seeking Details regarding C/o Road from Lassumpate to Tyarso via Taposo including 60 Mtr span bridge and 15 mtr sapn bridge , Sh:FC work CD, GSB, WBM-II and III and blacktopping,, Pakke Kessang District (1-8.5 KM) Rs. 2500.00 in lakhs under RIDF-XXIV during 2023-24.

As per the case record, PIO did not furnish sought information.

Being dissatisfied, the appellant filed First Appeal dated 19/02/2025. No hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Respondent : PIO-cum-EE (RWD), Pakke Kessang is represented by Er. Namdu Sonam.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tana Roma Tara on **19.02.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (RWD), Pakke Kessang Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17.08.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16.04.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 320/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 10/09/2025. In this hearing of the appeal on 10th day of September, 2025, the PIO-cum- Executive Engineer (RWD), Pakke Kessang is represented by Er. Namdu Sonam and the appellant Shri Tana Roma Tara present in person.

As per the order dated 10/09/2025, the appellant was directed to go through the documents furnished to him and intimate before the Commission on or before 16th September, 2025. The appellant was clearly caution that if no intimation is made to the Commission, it will presume that the appellant is satisfied by the information provided. Till today no intimation has been received from the appellant, so the Commission presumes that the appellant is satisfied by the information provided.

Accordingly, the appeal case is deemed fit to be disposed of. The appeal case No. APIC-320/2025 is disposed of and closed.
