Information sought :

The appellant file a RTI Application dated 25/10/2024 seeking Details regarding Extra amount funded/deviated amount on Rumgong to Yogong Village CRF Road.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 13/12/2024. No any hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Ganesh Tana Tara attended the hearing through VC.
Respondent : PIO-cum-EE(PWD), Rumgong Division found absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ganesh Tana Tarea on **25/10/2024** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Rumgong Division, Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-

A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **13/12/2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **31/01/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 116/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 09/07/2025, 06/10/2025 and 11/03/2026. In this hearing of the appeal on **11th day of March, 2026**, PIO-cum-EE(PWD), Rumgong Division, Siang District found absent without any intimation to the Commission and the appellant Shri Ganesh Tana Tara present through VC.

On the last hearing, the appellant was given time to intimate to Commission after collection of the information from the PIO. But the appellant failed to intimate inspite of giving sufficient time, after receiving the information from the PIO. The Commission presumes that the Appellant has received all the information.

Therefore, the appeal case is disposed of & closed.
