This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/07/2025 regarding Category of Work Charged (W/C) serving under Bomdila Division.
- 2). During the 2nd hearing held on 17th March' 2026 the appeal case was to be disposed of, however, Er. Thanu Rangradu, PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh had not submitted reply to the Show Cause Notice and valid reasons for absenting from the court hearing and therefore, the case was kept in abeyance.
- 3). The PIO vide letter No. BD/W-104/2025-26 dated Bomdila, the 23rd March 2026 has submitted valid Medical Reports / Medical Certificate to prove the reasons for absenting from the court hearing. The Commission, in view of the order dated 17th March'2026, decides to dispose of the case.
- 4). **Therefore the case is hereby disposed of.**
