**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Shoney Pertin for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Pasighat Division, East Siang District A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 29.04.2025.

**A) Particulars of information:** Seeking information relating to all the documents of Development of “Siang Adventure and Eco-Retreat” in Pasighat A.P

**B) Details of information:**

1. Furnish the certified copy of approved DPR along with Design and Drawing;
2. Furnish the certified copy of Sanction order;
3. Furnish the certified copy of NIT;
4. Furnish the certified copy of letter of acceptance, notice to proceed with the work and agreement copy.
5. Furnish the certified copy of EMD deposit of all the participants firm;
6. Furnish the certified copy of past work experience certificate submitted during tender period;
7. Furnish the certified copy of all the participant names of firms/ Contractor.
8. Furnish the certified copy of both the profile of contractors submitted during tender period;
9. Furnish the certified copy of bank guarantee copy of the contractor;
10. Furnish the certified copy of recommendation of the tender evaluation;
11. Furnish the certified copy of check list for evaluation of technical bid;
12. Furnish the certified copy of both the participant contractor registration certificate;
13. Name of the Newspaper in which NIT was actually advertised along the date and time;
14. Furnish the certified copy of Geo-tag colouring photograph of before and after execution of work;
15. Details of LOC received in respect of the project;
16. Certified copy of payment details of PFMS;
17. Furnish the certified copy of balance sheet and audit report;
18. Furnish the certified copy of comparative statement;
19. Furnish the name of officer who monitored the work;
20. Certified copy of physical and financial progress in percentage and
21. Furnish the certified copy of submission of affidavit and undertaking along with self-declaration.

**C) Period for which information asked for: 2025 to till date.**

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the appellant, Shri Shoney Pertin requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer, Central Zone-B, Pasighat, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 19.05.2025. Further records reveal that FAA had conducted hearing on 9th July, 2025 and disposed of the appeal as under:

***“ORDER***

- 1. This is an appeal under Section 19(1) of RTI Act, 2005 filed by Shri Shoney Pertin, for non-furnishing of requested documents by the PIO-Cum- EE (PWD), Pasighat Division as sought by the Appellant under Section 6(1) of RTI Act, 2005 regarding:-  
A. Development of Siang Adventure & Eco-Retreat in Pasighat, Arunachal Pradesh.*
- 2. On receipt of the above appeal, the case was admitted in this court and the First Hearing and Second Hearing of the case were conducted on 3/06/2025 and 24/06/2025 respectively. During the first hearings, the Respondent PIO was absent and the Appellant was present and on the second hearing both the PIO and the Appellant were present but due to non-availability of the documents the responded PIO could not presented the required document due to tender under process*
- 3. The third hearing of the case is conducted today i.e 09/2025. During the hearing both the respondent PIO and the appellant were present.*
- 4. The court heard the statement of both the respondent PIO and the Appellant and learned that the documents (DPR) are not available with the respondent PIO hence directed the respondent PIO to hand over the documents to the appellant as and when it is available.*

*With this, the Case stand disposed off.*

Apparently, the appellant failed to obtain the information and therefore, preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of Appeal dt. 22.10.2025.

This appeal is accordingly, listed and heard today on 27.02.2026.

The appellant, Shri Shoney Pertin and the APIO, Er. Shri Ringong Bitin, AE are present in person.

Heard the parties.

The APIO submitted that the appellant has been furnished with the requested documents except the copy of DPR (Sl. No.1 of the RTI application), the latest Geo Tag Photo of the project (Sl. No.14), the copy of LOC (Sl. No.15) and the payment details of PFMS (Sl. No.16).

The appellant also admitted of having received the rest of the information / documents but demanded for the left out documents as above.

As regards the DPR (Sl. No.1), the APIO submitted that the contractor/firm concerned who is executing the project in question has been advised to submit the complete set of Design, Detailed Drawing and DPR vide the PIO's letter dt.16.02.2026 and that the same shall be provided to the appellant as soon as the firm submits the same.

As regards the latest geotag photo (Sl.No.14), the APIO assured to furnish the same. As regards the copy of LOC (Sl. No.15), the APIO submitted that in respect of payment through PFMS, no LOC is issued and as regards the payment details of PFMS (Sl. No.16), the APIO assured to furnish detailed explanation to the appellant.

In the premises as above, the PIO is directed to furnish the left out information as above / and appropriate explanations as assured within 2(two) weeks from the date of receipt of this order.

This appeal is disposed of in above terms.
