





## ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC- 366/2025.

APPELLANT RESPONDENT : Shri Bamang Pacho, I.G Park, Itanagar.

## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.02.2025.

- A. Particulars of the Information: Under Budget Estimate (BE) 2023-2024.
  - 1. Maintenance and Renovation of various road under PWD, Sub-Division koloriang;
  - 2. c/o and improvement various road under PWD, Sub-Division Koloriang;
  - 3. Maintenance and Renovation road of Lubupa to Moruk Village Portrack and
  - 4. c/o Portrack from Marma to Subu village under Parsi-Parlo circle.

## **B.** Details of Information required

- i) Work order by particular name/firm.
- ii) MB Note
- iii) DPR
- iv) Cheque counter foil particular by name;
- v) LOC
- vi) 3 times geo tagged photo
- vii) Payment details
- viii) Details of credit amount
- ix) Details of account number ip which amount credited
- x) Bank & Branch Name which amount credited from concerned department
- xi) Completion Certificate.
- C. Period for which information asked for: 2023-2024

## **Brief facts emerging from the appeal**:

Records emerging from the appeal disclose that the appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer , (PWD), Central Zone-A, Itanagar, Govt. of A.P, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 04.04.2025 .

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, AP, Itanagar conducted a hearing on 25<sup>th</sup> April, 2025, wherein the appellant Shri Bamang Pacho was present but the PIO was absent. The FAA, after hearing the appellant, disposed of the appeal with the following direction:

"After hearing the case, it was found that the PIO has failed to reply/furnish the information as sought by the appellant in his RTI Form A received dated 22.02.2025 via post within the stipulated time period.

Therefore, the respondent PIO was directed to furnish all documents except information sought at Sl. No. iv i.e Cheque counter foil particularly by name, Sl. No. ix i.e Details of account number in which amount credited and Sl. No. x i.e Bank & Branch Name which amount credited from concerned department. Instead, the payment amount in writing should be provided to the appellant. The respondent PIO was directed to furnish the information by  $25^{th}$  May, 2025 without fail."

However, the appellant has preferred 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 05.05.2025 which is, accordingly, listed today on 7<sup>th</sup> Nov., 2025 for hearing. But both the parties are absent without any information.

This Commission is, therefore, of the view that the appellant is no longer interested in pursuing this appeal, presumably, because he had received the requested information after filing his 2<sup>nd</sup> appeal before this Commission as happens in many of the cases. Accordingly, this appeal stands closed in terms of the condition contained in the summon notice that "in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence."
