**Information sought:**

The appellant filed an RTI application dated 22.07.2025 seeking following information regarding Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB), Itanagar, AP.

**Details of information required:**

1. Furnish a copy of the Name List of RO (S), UDC (S), LDC (S), Peon (S) and other staffs of Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB), Arunachal Pradesh.
2. Furnish a Copy of the Appointment Order (s) of all the staffs (RO (S), UDC (S), LDC (S), Peon (S) other staffs) of Arunachal Pradesh & Other Construction Building (APB&OCWWB), Arunachal Pradesh. Workers Welfare Board
3. Furnish a Copy of the Present Posting Places of all the staffs (RO (S), RO In-Charge (S), UDC (S), LDC (S), Peon (S) and other staffs) of Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB), Arunachal Pradesh.

4. Furnish a copy of an Appointment Order before 2021 in respect to Shri Tadung Rigia as OSD to Chairman of Arunachal Pradesh Building & Other Construction Workers Welfare Board (APB&OCWWB), Arunachal Pradesh.
5. Furnish a copy of the Government Notification for the appointment of OSD in APB&OCWWB.
6. Furnish a copy of Government Notification prior to 2021 in respect to the appointment of Shri Tadung Rigia as OSD in APB&OCWWB.
7. Furnish all the documents with proper paging along with proper CTC within 30 days from the date of receipt.

Period for which information asked for: In regarding as per information Sought.  
The following were present.

**Appellant** : Absent. However, she has submitted a letter dated 13.4.2026 requesting the commission to allow to withdraw her appeal case as she has received satisfactory information from the concerned PIO.


**The appeal case is disposed of accordingly at this Commission.**
