Information sought :

The appellant file a RTI Application dated 14/09/2023 seeking Details regarding
Revise Estimate (RE) Scheme.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 23/11/2023. No hearing has
been conducted by the First Appellate Authority in this regard. Feeling aggrieved and
dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Bini Toluk absent.

Respondent : PIO-cum-EE (PWD), Raga Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bini Toluk on **14.09.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Raga Division, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.11.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **05.01.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 11/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 9 (nine) time i.e on 19/08/2024, 16/09/2024, 28/10/2024, 18/11/2024, 09/12/2024, 03/02/2025, 17/03/2025, 21/04/2025, 09/06/2025 and 07/07/2025. In this hearing of the appeal on 7th day of July, 2025, The PIO-cum-EE(PWD), Raga Division, Kamle District present in person but the appellant Shri Bini Toluk found absent, however he sent a letter requesting to dispose of the appeal Case No. APIC-11/024 and APIC-12/2024.

Bailable Warrant Arrest order was issued against the PIO-cum Executive Engineer (PWD), Raga Division but it is seen that Warrant of Arrest was not executed by the Police Department Raga. It is reported that order for Warrant of Arrest not received by the Police Department till date.

Today the PIO-cum-EE(PWD), Raga Division present, so the Commission recalls the Bailable Warrant of Arrest order issued against the PIO under Section 151 of CPC, 1908.


The Commission accepted the request letter submitted by the appellant to dispose of the appeal case as he has received all the documents and satisfied.
