ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near, KV2 School, Chimpu, Itanagar, Arunachal Pradesh for non-furnishing of information by the SPIO-cum- District Agriculture Officer (DAO), Govt. of A.P. o/o District Agriculture Development Officer, Namsai, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/05/2023 regarding Cultivation of Ginger, Namsai District, Arunachal Pradesh.

The 3rd hearing is held today on 26th March, 2024 as scheduled. Shri Kago Taya, the PIO-cum-District Agriculture Officer (DAO), Govt. of A.P. Namsai, Namsai District, Arunachal Pradesh, is alone present. The Appellant Shri Tamchi Gungte is absent. The PIO reiterated that he has already furnished information to the appellant through Postal service on 12/12/2023.

In the 1st hearing held on 17th October, 2023 the PIO had furnished the authenticated additional information in the commission's court room. On appeal of the appellant the commission had directed the PIO to furnish the newspaper cutting of the advertisement, NIT copy and payment details which was agreed to be done by the representative of the PIO.

In the 2nd hearing held on 12th December, 2023 the appellant was absent, the representative of the PIO had brought hard copies of information in the court room. The commission had directed the representative of the PIO to send the information through postal service. The commission giving reasonable opportunity to the appellant fixed one more date of hearing with a cautioned that if the appellant remains absent in the next date of hearing the case shall be disposed of presuming that the appellant has received the information and is satisfied with the same.

The Commission decides to dispose of the case with liberty to the appellant to apply a fresh application in Form-A to the PIO if wish to seek additional information if any. The commission hereby disposes of the case for larger public interest.

Therefore, the case is hereby disposed of.

Order copies be issued to all the parties.
