JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Kipa Natung on **25/04/2025** filed an RTI application in form 'A' before the PIO-cum-Director, APEDA, Itanagar, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **22/05/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11/11/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **401/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **17/03/2026 & 02.06.2026.**

Details of Information sought from the PIO;

PART-1

1. Furnish CIC of sanction order copy of the Project: C/o Super ECBC Building Project under Bureau of Ener Efficiency, Gol at Doimukh with sanctioned amount of Rs. 698.42 Lakhs.
2. Furnish CTCs of NIT and its publication in any local daily.\
3. Furnish CTCs of DPR & TS of the said project.
4. Furnish number of firms participated in the competitive bidding process along with comparison chart of the amou quoted by all the firms.
5. Furnish contact details of the contractor/proprietor of the firm whom the work is awarded.
6. Furnish CICs of details of firm (s) whom the construction of the said project is awarded.
7. Furnish CTCs of present physical and financial status along details of expenditures made against the said project till date.
8. Furnish CTCs of payment details viz. Banker's check/Check counterfoil/check leaf/PFMS Voucher of all the financia transactions made till date.
9. Furnish CTCs of Utilization Certificates of all the funds allocated against the said project till date.

PART-11

1. Furnish CTCs of fund Division-wise allocation details of funds of Rs. 941.23 Lakhs allocated for PM-KUSUM Scheme for the financial year 2024-25.
2. Furnish CTCs of lists of farmers selected for PM-KUSUM Scheme.
3. Furnish CICs of firm(s)/Company(s) selected for supply of material components of the PM-KUSUM Scheme
4. Furnish CICs of any other projects taken up in connection with PM-KUSUM Scheme.

In the Second hearing held on 2nd June' 2026 both the parties absent without intimating the reasons for their absence.

The Commission's observations;

- i) In the last hearing held on 17th day of March' 2026 the representative of the PIO had stated in the court of the Commission that all the information(s) have been compiled and readied at the office of the PIO and the Appellant may collect the information from the office of the PIO on any working day.
- ii) The Commission had ordered on 17.03.2026 to the Appellant to collect the information from the office of the PIO and to be present in the next hearing without fail to let the Commission know about the complete receipt of the information as applied and failing to attend the next hearing which is today, the Commission had ordered that this appeal will be heard and determined ex-parte.
- iii) In the absence of the Appellant despite order from the Commission to be present in the next hearing signifies that he is not serious on his appeal, and therefore, has not bothered to intimate whether he has received the information from the PIO or not and also he has not bothered to let the Commission know regarding the reason for his absence today in the hearing.

Under the above observations the Commission hereby taking seriously the absence of the Appellant despite strict order by the Commission to be present in the hearing today, the Commission hereby dispose of this appeal.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed.
