**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Nabam Nanu, on **27/08/2024** filed an RTI application in form 'A' before the PIO-cum-DDSE, Yupia, Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **14/10/2024**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **17/02/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **152/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **05/08/2025 & 13.11.2025.**

Details of Information sought from the PIO;

1. Furnish the Government notification copies of total amounting sanction order and mentioned work of School boundary wall under the which head of Account and financial year. All of the above mentioned schools published in which local newspaper.
2. Furnish the copies of Government floated notice inviting tender (NIT) for C/o school boundary wall. All of the above mentioned schools published in which local newspaper.
3. Furnish the copies of technical bids and financial bids response and non response evaluation result sheets. All of the above mentioned schools.
4. Furnish the copies of letter of commencement of work for the C/o School Boundary Wall. All of the above mentioned schools.
5. Furnish the copies of letter of acceptance of work for the C/o School Boundary wall. All of the above mentioned schools.
6. Furnish the copies of letter of work order from the Department to contractor and any others parties. All of the above mentioned schools.
7. Furnish the copies of three stages colour photographs and three stages of Geo-Tagged points of the before, during and after completion of work. All of the above mentioned schools.
8. Furnish the copies of completion certificate from department. All of the above mentioned schools.
9. Furnish the copies of completion certificate/NOC from concerned School Head Master/Teacher In-Charge Public representative and SMC Chairman. All of the above mentioned schools.
10. Furnish the copies of payment details amount [paid through cheque, PFMS, Firms name or any types of transaction. All of the above mentioned C/o School boundary wall,
11. Furnish the copies of name of executing agency for the above mentioned schools.
12. Furnish the copies details project Report (DPR). All of the mentioned schools.
13. Furnish the copies of technical sanction order (TS) approval by the technical staffs such as Junior Engineer (JE). Assistant Engineer (AE), Executive Engineer (EE) and Superintending Engineer (SE) etc. All of the above mentioned Schools.

14. Furnish the copies of original schools boundary demarcation mapping and LPC copies.  
All of the above mentioned Schools.

The PIO-cum-DDSE, Yupia, Papumpare District, Govt. of Arunachal Pradesh found absent without intimating the Commission, the reason for his inability to attend the hearing.

**Heard the Appellant;**

The Appellant stated that the PIO has provided the same information repeatedly to him and requested the Commission to dispose this instant appeal with liberty given to him to file fresh application, for information for the completed works.

**After hearing the Appellant the Commission hereby orders**

As the information as sought by the Appellant have been furnished by the PIO, there is no need to further hear the appeal.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.
