An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC-350/2025.

APPELLANT

: Shri Tamchi Gungte, near KV-II School Chimpu Itanagar.

RESPONDENT

: The PIO, o/o the Executive Engineer (RWD), Aalo Division, West Siang District (A.P)

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (RWD), Aalo Division, West Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 05.02.2025:

Particular of information: c/o "Construction / upgradation of roads and Bridge under Pradhan Mantri Gram Sadak Yojana" during the financial year 2024-25.

The total list of work / project are as follow:

1. BRTF Road to KugiPomse.
2. Gadi Mesi to Kagi Gadi
3. MRL 10-Pakam to Ushi via Kombo Pomte.
4. Dojijeku to Ngomdir.
5. Liromoba HQ to VKV School.
6. Darak to Belo.

Details of information required:

1. The certified sanction order copy.
2. The Certified copy of proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Assembly Constituency as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
3. The certified PRC Submitted by tender Participant issued by the Competent Authority regarding domicile status within the District as per Rule 4(ii)(b) of the Arunachal Pradesh District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
4. The name of firms who won the tender work with respect to subject mentioned above.
5. The name of officers and their Designation at the time of monitoring the work.
6. The certified copy of contractor Registration, of the tender participant and tender winning firm.
7. The certified copy of contractor Enlistment (Civil), of tender participant and winning firm.

8. The certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per Arunachal Pradesh Gazette Notification no. SPWD/W-66/2012 dtd. 01-08-2018 and as per District Based Entrepreneurship Act, 2015 & 2020).
9. The certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
10. The certified copy of all Photograph of work items (Glossy paper) before starting of work and Photograph (Glossy Paper) after completion of work.
11. The certified Payment Details (Cheque no., voucher, PFMS/ etc. (Which ever method is used of payments) of the project till date.
12. The certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
13. The certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.

Facts emerging from the appeal:

Ther records in the appeal reveal that the appellant failed to obtain the requested information from the PIO which prompted him to file his 1st appeal under section 19(1) of the RTI Act before the CE (RWD)(WZ), Itanagar, the First Appellate Authority (FAA) vide his memo of appeal dt.18.03.2025. But having failed yet again to receive any positive response from the FAA, the appellant preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act 2005 vide his Memo of Appeal dt.19.07.2025.

Hearing and decision:

This appeal was heard 4 (four) times on 03.10.2025, 12.11.2025, 16.01.2026 and 11.02.2026.

On 03.10.2025, the appellant, Shri Tamchi Gungte was present but the PIO was absent. On 12.11.2025, the appellant did not attend the hearing but the PIO, Er. Shri Gambi Karbak, EE was present in person with the replies to the RTI queries of the appellant. But since, the appellant was absent, the replies furnished vide letter dt.06.11.2025 by the PIO could not be handed over to the appellant and the appeal could not be heard.

The hearing of this appeal was, accordingly, adjourned to 16th January, 2026 when the PIO was absent without any intimation while the appellant was present in person who was handed over the replies furnished by the PIO with direction to go through the same and submit his rejoinder/dissatisfaction, if any, thereon on the next date on 11.02.2026.

Today on 11.02.26, the appellant is, however, absent without any information but the PIO, Er. Shri Gambi Karbak appeared through VC who submitted that the appellant has been furnished with the requested documents/information and as such the appeal be disposed of and closed as such.

This Commission is also of the considered opinion that the appellant is satisfied with the requested documents / information furnished by the PIO which were handed over to him on 16.01.2026 and therefore is no longer interested in the adjudication of his appeal in this Commission.

This appeal is, accordingly, disposed of and closed in above terms.
