ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Shoney Pertin, District President (NPP), Airfield Pasighat, Ward No-4, Po/Ps-Pasighat, East Siang District, for non-furnishing of information, by Shri P.K. Thungon, PIO-cum-EE(UD & Housing), Pasighat Division, East Siang District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 18/09/2020 regarding ongoing construction work at Mebo constituency in the year 2019.

Whereas, the 1st hearing was held on 16th February'2021. Shri P.K. Thungon, PIO-cum-EE(UD & Housing), Pasighat Division, East Siang District, Arunachal Pradesh, was found absent during the hearing. However, the PIO was represented by Shri Kaling Taloh, Junior Engineer, UD & Housing, Pasighat Division. The Appellant Shri Shoney Pertin was present. The representative of the PIO informed the Commission that due to expiry of Mother-in-law the PIO could not come for the hearing. The Appellant informed the Commission that the information sought at Form-A Sl.no. 6 has not been furnished and some pages of information furnished for Sl.no. 1, 2, 3, 4, & 10 are not legible. The representative of the PIO, for Sl.no. 1, furnished legible Sanction Order copy during the hearing, but DPR and other information were not brought in the court. The representative of the PIO informed that legible information are available in the office.

Whereas, the Commission after hearing both the parties directed the PIO to furnish correct, complete, authenticated and legible information for SI.no. 1, 2, 3, 4, 6 & 10 to the Appellant within ten days from the date of issue of this order. The Commission asked the Appellant to receive the information, go through and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held on 23rd March'2021. Shri P.K. Thungon, PIOcum-EE(UD & Housing), Pasighat Division, East Siang District, Arunachal Pradesh, and the Appellant Shri Shoney Pertin were present during the hearing. The information was handed over to the Appellant in the court, during the hearing, the Appellant went through the information and conveyed his satisfaction.

Therefore, the case is hereby disposed of.
