JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Tania June & Shri Nikam Dabu, C/o Post Office Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO, O/o the DC Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 19.09.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Appointment of UDC/ LDC/ Peon/ Contingence/ Driver/ Group B,C,D/ All MTS Posts for the period 2010 to 2022 (till date)."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 8th day of February'2023. The Appellant was present but the PIO was absent. The PIO had forwarded a letter through WhatsApp on 06/02/22 communicating the appellant to pay the amount of the Xerox charges. The court directed the appellant to do the same and collect the documents from the PIO's office and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case.

The 2nd hearing for the case was held on the 22nd day of Feb'2023. The appellant was present but the PIO was absent. Durin the hearing of this case the appellant informed the Court that his joint petitioner Shri Nikam Dabu had left for Daporijo to collect the documents from the PIO and would inform his satisfaction/dissatisfaction on or before the next date of hearing of this case.

The 3rd hearing of the case was held on the 19th day of April'2023. The Appellant was present but the PIO was absent. Therefore, the case couldn't be heard. However, the PIO had written a letter intimating that the appellant hadn't turned up to collect the documents as sought after submitting the chal/an. Hence, the appellant had been directed by the Court to approach the PIO's office to collect the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case.

The 4th hearing of this case was held on the 9th day of Aug'2023. The appellant was present but the PIO was absent. During the hearing of this case the appellant informed the Court that he had gone through the information provided by the PIO and stated that he hadn't received all the documents as sought by him. The Court directed the PIO to furnish the left-out information on or before the next date of hearing of this case failing which necessary action would be taken against him as per relevant sections of the RTI Act,2005.

The 5th hearing of this case was held on the 30th day of Aug'2023. The appellant was present but the PIO was absent. The Court/Commission seriously viewed the absence of the Pio for 03(three) consecutive times without any intimation or sending any representative on his behalf and not providing the information as sought by the appellant. A Show Cause Notice was issued to the PIO for his appearance on the next date of hearing of this case.

The 6th hearing of this case was held on the 14th day of Sept'2023. Appellant was present but the PIO was absent. However, the PIO was contacted over phone and has been directed to provide the left-out information as sought by the appellant on or before the next date of hearing of this case.

The 7th hearing of this case was held on the 18th day of Oct'2023. Both the parties were present. After hearing both the parties, the PIO had been directed by the Court to provide the left-out documents as sought by the appellant on or before the next date of hearing of this case.

The 8th hearing of this case was held on the 16th day of Nov'2023. Both the parties were absent. The case couldn't be head. The Court fixed the next date of hearing of this case on the 20/12/23 with a direction to the PIO to furnish all the information sought by the appellant on or before the next date of hearing of this case.

On 26/12/2023 the PIO sent the Copy of the documents through WhatsApp which had already been provided to the appellant by post on 12/06/23 (copy enclosed for ready references). Therefore, there is no information left to be provided to the appellant. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.

After waiting few months, all the required information/documents have already been registered by post to Sri Tania June and Sri Nikam Dabu on 121" June/2023 as per given address i.e. Hotel chandni. Naharlagun vide letter even No. dtd 23rd Feb/2023 (Letter & Registered copy enclosed).
