## **JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Riya Taram on 17/4/2022 filed an RTI application under Form-'A' before the PIO-Cum- EE, (PWD) Palin Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 17/5/2022, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 20/6/2022 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 570/2023(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 5<sup>th</sup> hearing on 28<sup>th</sup> October'/2025.

## Details of information sought by the Appellant.

- 1. Furnish Details Project Report (DPR).
- 2. Give Technical Sanction (TS) copy.
- 3. Furnish the Name of Work/Scheme/Project.
- 4. Photograph with Global positioning System (GPS) Co-ordinates/Geo-tag.
- **5.** Geo-tag and photograph of every works/Video recording of work site from starting to ending.
- **6.** Provide list of Cheque leafs/counterfoil/Cash memo/Bank transaction Records of payment.
- 7. Details of PFMS Account Transaction with account numbers if payment has made through PFMS.
- 8. Give the Details of Measurement Book (MB) with page no....
- 9. Photograph of scheme.

- 10. Utilization certificate signed by PWD Commissioner/SE/EE.
- 11. Details of Contract/Agreement between Working Agency department and Contractor.
- 12. Give the Work Order copy.
- 13. Furnish the First and final bill copy.
- **14.** Furnish the Name of Firm/Contractor/Enterprise/individual with their Bank account Number or Cheque leaf/demand draft etc whose the Bill has been passed/Transaction through PFMS.
- 15. Give the Cash book with page numbers or Give hand Receipt with payees Name.
- 16. Furnish the Forwarding letter from EE PWD division office Tawang
- 17. Estimate copy.
- 18. Detail of payment made to the Contractor/Billing as per desire.
- 19. Give the Billing challan/cash memo.
- **20.** Furnish the details record of payment made/Transferred to the contractor/Firm/Enterprise as per tender Agreement.
- **21.** Give the Details On What basis the payment has made to the contractor or firm in the form of cash/Cheque.
- 22. List of tender participants copy.
- 23. Give the Social Audit copy.
- 24. Third party inspection Record.
- **25.** Give the Bank Account Statement of Department before or after the payment made/Transferred to the contractor/Firm/Enterprise/individual.
- 26. Furnish the NIT copy/ tender advertisement publication in local daily news paper if any.
- 27. Give the Details which date tender has conducted.
- **28.** Give all the Files Approved by District vigilance Officer cum. Deputy commissioner Kra-dadi District.
- **29.** Give the Certified copy of LOC/LOA receipt from Finance department/Chief Engineer office.
- **30.** Copy of work completion Report/UC
- 31. Name of contractor/Firm/Enterprise/individual along with latest GST Update Number.
- **32.** Give Reason for Deduction of Money from Contractor/Firm/Enterprise/individual Fund like Contingency/GST/Royalty charges as per govt. guidelines.
- **33.** Furnish the Name of Officers/Officials those who handling the above mentioned Fund Allocation
- **34.** Furnish the Staff list like computer operator, peon, driver and casual labour with Appointment Order Copy/Education Qualification /Pay rolls of above mention staffs from 2016 to till date.
- **35.** Please furnish the details amount under salaries heads of account from 2017 to till date with list of staffs and bank account numbers as well as monthly salaries and other incentive money deposited as per CPWD Prescribed manual form.

In the 5<sup>th</sup> hearing on 28<sup>th</sup> day of October '2025, the Appellant found absent, with a letter dated 24/7/2025, submitted to the Commission the day before. The PIO –cum, Executive Engineer (PWDD) present during the hearing in person.

The Appellant Shri Riya Taram, has submitted a letter to the Commission dated 24/7/2025 stating that he has received all the information(s) as sought in his Form 'A'

application and has requested the Commission for disposal/closure of his appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
