**Information sought :**

The appellant file a RTI Application dated 10/06/2025 seeking Details regarding provide copies of all complaint letter/application made against Shri Takar Jamoh at EAC Office, Mahadevpur, Namsai District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 15/07/2025. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Takar Jamoh present in person.

Respondent : PIO-cum-EAC, Lekang Circle found absent.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Takar Jamoh on **10/06/2025** filed an RTI application under Form-'A' before the PIO-cum-EAC, Lekang Circle, Mahadevpur, Namsai District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **15/07/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/08/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 638/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 24/09/2025 and 08/12/2025. In this hearing of the appeal on **8<sup>th</sup> day of December, 2025**, appellant Shri Takar Jamoh present in person but the PIO-cum-EAC, Lekang Circle, Mahadevpur, Namsai District found absent without any intimation to the Commission.

Appellant stated before the Commission that all the information sought by him are been provided though it is not his satisfaction as doubted that documents are not correct one. The Commission has no authority to decide the documents provided are correct or incorrect. The Commission can only direct the public authority to provide information sought by the appellant.

Therefore, this appeal case disposed of and closed.
