The appellant file an RTI Application dated 29/04/2025 seeking Details regarding Siang Adventure and Eco- Retreat in Pasighat, Arunachal Pradesh.

Being dissatisfied, the appellant filed First Appeal dated 19/05/2026. The First Appellate Authority has been conducted hearing in his jurisdiction on 03/06/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGMENT/ORDER**

This is an appeal filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Shoney Pertin 29/04/2025 filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A

application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19/05/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29/10/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 13/C/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> time i.e on 20/-4/2026. In this hearing of the appeal on 20<sup>th</sup> day of **April, 2026**, the PIO-cum-EE (PWD), Pasighat Division and the appellant Shri Shoney Pertin found absent. however, the appellant has submitted a letter requesting to dispose of the case. Request accepted and the appeal case is disposed of and closed.
