JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Rechi Thomas, Jollang, Itanagar, PO- RKM, ICR, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Executive Engineer, Rural Works Department, Itanagar Division, Itanagar Capital Region, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 06.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding :

"C/o Protection wall at Jollang River at Jollang Village – 120 mtrs."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on 15th day of February' 2023. The appellant was present but the PIO absent. The case was heard ex-parte. Since the PIO was absent the matter couldn't be discussed further. As such, the Court fixed another date of hearing for the case on 01st March 2023.

The 2nd hearing for the case was heard on 01st day of March' 2023. The appellant was present but the PIO was absent. The APIO represented the case on-behalf of the PIO. Heard both the parties. The APIO furnished the information sought by the appellant before the Court itself. The appellant received the same. The Court directed the appellant to go through the documents received and inform his satisfaction/dissatisfaction for the documents on or before the next date of hearing fixed on 26th April' 2023.

The 3rd hearing for the case was heard on 26th day of April' 2023. Both the parties were absent. The APIO represented the case on-behalf of the PIO. The case was heard ex-parte. The APIO informed the Court that all the documents sought by the appellant has been furnished by the PIO and the appellant had received the same. Since, the appellant was absent during the hearing without any intimation to the Court on many occasions, the Court assumed that the appellant is no more interested in the case and further directed to dispose of the case. As such the Court ordered to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
