Information sought :

The appellant file an RTI Application dated 22/02/2025 seeking Details regarding furnish all the relevant information against the implementation and development works under the funding head of Budget Estimate (BE) rom 2020-2025.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 24/03/2025. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Bengia Tahar & Lokam Namdu absent.
Respondent : PIO-cum-EE (WRD), Palin Division absent.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bengia Tahar & Lokam Namdu on **22.02.2025** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (WRD), Palin Division, Kra-Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Anneal before the First Annellate Authority on **24.03.2025**. Annellant. again having

not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28.04.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 342/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 03/09/2025. In this hearing of the appeal on 3rd day of September, 2025, PIO-cum-EE (WRD), Palin Division and the appellant Shri Bengia Tahar & Lokam Namdu found absent. However, a letter addressed to the Commission has submitted by the appellant Shri Lokam Namdu stating that all the information as sought by him has already been provided by the PIO and he is satisfied with the information provided and he requested to dispose of the appeal case No. APIC-338/A/2025. Request accepted and this case is disposed of and closed.
