JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bengia Tahar & Lokam Namdu on 22.02.2025 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (WRD), Palin Division, Kra-Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 24.03.2025. Appellant, again having

not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28.04.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 342/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 03/09/2025. In this hearing of the appeal on 3rd day of September, 2025, PIO-cum-EE (WRD), Palin Division and the appellant Shri Bengia Tahar & Lokam Namdu found absent. However, a letter addressed to the Commission has submitted by the appellant Shri Lokam Namdu stating that all the information as sought by him has already been provided by the PIO and he is satisfied with the information provided and he requested to dispose of the appeal case No. APIC-338/A/2025. Request accepted and this case is disposed of and closed.
