#### JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Lebe Lamnio, New Seppa, PO/PS-Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information, by the PIO-cum-EE, PWD Bameng Division, East Kameng District, Govt. of Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 31.05.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Construction of Boundary Wall surrounding of Lamnio iv School is East Kameng District for the year 2021 to 2023 (till date)."

## The above subject has been mentioned in detail under 'Form -A'.

The 1<sup>st</sup> hearing for the case was held on the 24<sup>th</sup> Day of January' 2024. The appellant was present but the PIO was absent. Hence, the case couldn't be heard. Therefore, the Court/Commission has fixed the next date of hearing.

The 2<sup>nd</sup> hearing of this case was held on the 31<sup>st</sup> day of January'2024. The appellant was present. The PIO was absent but the PIO came to the Information Commission on the 1<sup>st</sup> Feb'2024 and informed that he had received the Summon Order lately due to which he couldn't attend the previous hearing. Further, he informed that he had already furnished the information to the appellant vide letter no. BMGD/RTI-46/2023-24/468 dated Bamang 02/02/2024 (copy enclosed for ready references). As such there is no more information to be provided to the appellant. Hence the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
