**Information sought :**

- The appellant filed an RTI Application dated 06/06/2025 seeking Details regarding
- Category of Work charged W/C serving under the Division & Sub0division.
  - Appoint letter, place of posting etc. of W/C staff under the division.
  - Present strength, new strength and sanction strength of W/C staff under the Division. Recruitment Rules and approval of the competent authority etc.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 15/07/2026. First Appellate Authority had conducted the hearing in his jurisdiction on 25/07/2025. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Appellant : Shri Ashok Sangbia absent.  
Respondent : PIO-cum-EE (Electrical) Seppa Division present.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ashok Sangbia on **06/06/2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Electrical), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **15/07/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **26/08/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 661/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 09/02/2026 and 18/05/2026 In this hearing of the appeal on 18<sup>th</sup> day of May, 2026, the PIO-cum-EE (Electrical), Seppa Division present in person but the Appellant Shri Ashok Sangbia found absent without any intimation to the Commission.

On the last hearing dated 09/02/2026, the PIO was present and stated before the Commission that all the information sought by the appellant has already been provided. As per the order of the First Appellate authority also the documents sought has already been provided to the appellant.

The appellant filed an appeal case before the Commission stating that he is not satisfied by the information given by the PIO.

The appellant was directed to submit in writing to seeking specific information which has not been provided as per his Form 'A' application to the Commission. The appellant was cautioned that if no such intimation is made, the Commission will presume that appellant is satisfied by the information provided and the appeal case will be decided accordingly.

Today the appellant absent and he has not made any intimation as directed. Therefore, the Commission presumes that appellant is satisfied by the information provided.

Accordingly, this appeal case is disposed of and closed.
