JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **Riya Taram & Shri Takam Sakap, C/o Hotel Chandini, E-Sector, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **PIO –cum- EE, PHE&WS, Itanagar Division, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 31.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

“To furnish all the relevant documents of entire PHE&WS Seppa Division against allocation of fund under Jal Jeevan Mission (JJM) for support Activities from Mission Director Govt. of AP etc”.

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 07.06.2023. The appellant was represented by Shri Nikam Dabu and the APIO Er Tad Logi, AE, PHE&WS Itanagar Division was also present. Heard both the parties. The APIO requested the appellant to be specific of the information sought by him as per his Form-A. The Court directed the APIO to provide the specific information pertaining to JJM, BE on or before the next date of hearing of this case fixed on 14.06.2023.

The 2nd hearing of this case was held on 14.06.2023. The appellant was present, and Er. Tad Logi, AE PHE & WS Itanagar represented on behalf of the PIO. Heard both the parties. The APIO has been directed to provide the information as sought by the appellant as per his Form A on or before the next date of hearing of this case fixed on 05.07.2023.

The 3rd hearing of this case was held on 05.07.2023. The appellant was present and Er. Tad Logi, AE PHE&WS Itanagar represented on behalf of the PIO. Heard both the parties. Documents provided by the representative of the PIO during the court proceedings itself and the appellant has been directed to go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 02.08.2023.

The 4th hearing of this case was held on 02.08.2023. The Appellant was present and Er Tad Logi, AE, PHE&WS Itanagar represented on behalf of the PIO. Heard both the parties. Appellant informed the Court that the information furnished to him during last hearing is incomplete. The list of incomplete/left-out information would be provided by him(appellant) to the PIO/APIO and the PIO/APIO should provide the same to the appellant on or before the next date of hearing of this case fixed on 30.08.2023.

The 5th hearing of this case was held on 30.08.2023. The Appellant was present, but the PIO was absent. Therefore, the case couldn't be heard. The next date of hearing of this case is fixed on 14.09.2023.

The 6th hearing of this case was held on 14.09.2023. The Appellant was present. But the PIO was absent. The case was heard ex-parte. On going through the Form, A of this case as submitted by the Appellant it found that the information sought by him relates to Seppa PHE&WS Division, whereas the PIO of this case is Itanagar PHE &WS Division. As such, the Court decided to dispose of this case due to wrong addressed mentioned in the particulars of information sought by the Appellant as per his Form A with a liberty given to the appellant to file a fresh with necessary correction of his Form A.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
